Adult Basic Education Program numbers increase in 2010

In FY 2010, the Adult Basic Education Program saw another overall increase in its service numbers, consistent with the trend over the last several years. The program continues to accept students as space and resources allow.

In conclusion of its 20th year of service, the Program reported the following:

- A total of 261 active students received 8,484 hours of instruction.
- More than 75% (6,397) of the hours of instruction were provided by 186 community volunteers.
- Students in the program represented 49 countries from around the world.
- The majority of students in the program (92%) were immigrants.
- CMC's U.S. Citizenship class assisted 41 students; 13 became U.S. citizens in FY 2010.

Adult Basic Education program highlight:

- A math lab is offered to students interested in GED preparation or improving their basic math skills. In FY10, the lab saw a tremendous increase in students and added additional times to serve more students. These labs average 6-8 students with both GED students and English Language Learners attending each week. Volunteer tutors staff the math labs.



Volunteers

Volunteer hours at the Center surged in FY 2010. For the year, 437 volunteers provided 15,925 hours of service; an increase of 31% from FY 2009. Per the Alliant Energy Foundation, Inc., each hour of volunteered time equals \$20.25 meaning volunteers gave a total of \$322,481 to CMC!

In FY 2010, former CMC volunteer tutor Sr. Mary Janine Wolff, BVM, and Catherine's Comfortable Tea's "Tea Ladies" received the Iowa Governor's Volunteer Award from Iowa Governor Chet Culver. Sr. Janine was acknowledged for 10 years of volunteer service while the Tea Ladies received an outstanding group volunteer award.

Catherine McAuley Center Programs

Adult Basic Education

The Adult Basic Education Program provides on-on-one tutoring at no cost to adult English Language Learners or those who are striving to improve basic reading and math skills, studying for the General Educational Development (GED) test or preparing for the U.S. citizenship exam. The goals of the Program are to promote the welfare and dignity of native and non-native English-speaking adults, to recruit and train volunteers to assist staff with Program services and to provide support services to immigrants and refugee clients and the broader community.

Transitional Housing Program

The Transitional Housing Program serves homeless and near-homeless women age 18 or older without children in their care, providing them with safe housing and staff support as they learn to set goals, address problems that led to their homelessness and prepare to establish and maintain permanent housing. The program is designed to help residents learn skills needed to maintain employment, address individual challenges, establish short- and long-term goals, maintain sobriety, follow rules, develop healthy relationships, pay bills/fees on time and build self-esteem.

Food Pantry

Since many of CMC's clients and families live below the federal poverty level, CMC stocks an in-house food pantry to help alleviate food costs. Thanks to a partnership with HACAP, CMC is able to purchase non-perishable items at an extremely reduced price. In FY 2010, CMC's food pantry served approximately 70 households and 229 people each month.

Transitional Housing Program continues to grow

The Transitional Housing Program continues to see an increased need for long-term housing services in the Cedar Rapids community. The program served fewer women in FY 2010 than in FY 2009. However, the nights of shelter provided increased by 8%, showing that residents understand and use the rehabilitation components of the program instead of using the program for brief shelter.

In conclusion of its 20th year of service, the Program reported the following:

- Thirty women from the ages of 20 to 57 were provided with 4,139 nights of shelter. The average length of stay was 204 days, up 57% from FY 2009.
- Of the 30 residents, 3 received mental health service, 1 received substance abuse services, and 21 received both mental health and substance abuse services.
- Residents participated in 50 Healthy Women's sessions, receiving instruction in independent living skills, positive decision-making, and building healthy relationships.

Transitional housing program highlights:

- Residents created an Empowerment Committee to assist those who have been affected by the rise in unemployment rates. The committee currently sells handmade bracelets and uses the revenue to help fund the residents' annual retreat and purchase emergency essentials.
- Through a grant from the Greater Cedar Rapids Community Foundation and the generosity of Prairiewoods Spirituality Center, the residents of the program were able to hold an educational and self-exploration retreat at the Prairiewoods facility.
- The program held its First Annual Women's Equality Day event to celebrate the passage of the 19th Amendment and to increase awareness of the history of women.

Fundraising Highlights

Fundraising in FY 2010 saw an 81% increase of giving by individuals through personal gifts and an increase in the support/attendance of CMC's special events. The Center received funding from 3 new grants this year and additional funding through another 19 grants. Overall, however, income from grants was down 35%. CMC is making efforts to find additional grant opportunities for the next fiscal year. The year's largest fundraising event was the annual Tea Party, raising more than \$18,571. Events raised an overall total of \$65,292, while donations for the year totaled \$89,494.

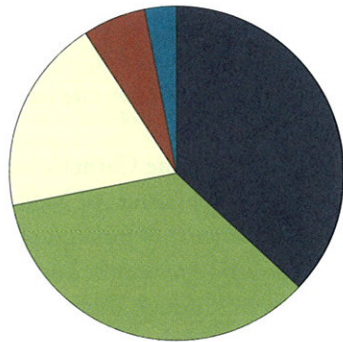

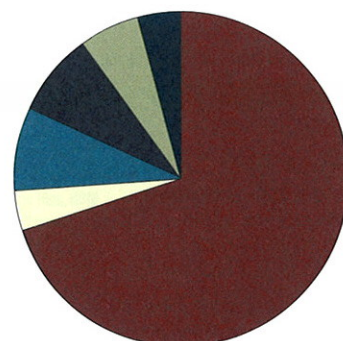
